## FSA/HSA/HRA Qualified Medical Expenses

This is a quick reference list of expenses that can be reimbursed from a flexible spending account (FSA), a health savings account (HSA) or a health reimbursement arrangement (HRA).

Medical expenses allowed as deductions are determined by Section 213 (d) of the Internal Revenue Code. However, eligible medical expenses under an HRA draw from this list of deductible medical expenses, but may exclude some expenses in the plan design. - · Health club or gym dues
- · Household help
- Illegal operations and treatments
- Maternity clothes
- Medicines and drugs from other countries (unless FDA approved)
- Nonprescription drugs and medicines
- Nutritional supplements
- · Personal use items
- Swimming lessons
- Teeth whiteningVeterinary fees
- Weight-loss program (unless for treatment of a specific disease diagnosed by a physician)

#### Ineligible Over-the-Counter Drugs/Items

- Cosmetics (including face creams/moisturizers)
- Lip balm (including ChapStick® or Carmex®)
- Medicated shampoos and soaps
- Toiletries (including toothpaste)
- Vitamins (daily), dietary supplements
- Weight-loss drugs for general wellbeing

# Dual Purpose Over-the-Counter (OTC) Drugs/Items

Some dual purpose OTC items can be reimbursed if they are used for a medical purpose. You must have a medical practitioner's note stating that you have a specific medical condition and the practitioner recommends the OTC item to treat it.

- Acne treatment
- Dietary supplements/herbal medicines
- Fiber supplements
- Glucosamine/chondroitin for arthritis or other medical condition
- Hormone therapy/treatment for menopause
- · Orthopedic shoes and inserts
- Pills for persons who are lactose intolerant
- Prenatal vitamins
- St. John's Wort for depression
- Sunscreen
